ORDINANCE NO. 27

**AN ORDINANCE TO PROVIDE EXAMINATION LEADING TO THE
BACHELOR OF ENGINEERING DEGREE UNDER FACULTY OF ENGINEERING &
TECHNOLOGY**

WHEREAS, the Solapur University approved the new syllabus of FACULTY OF ENGINEERING & TECHNOLOGY from the Academic Year 2012-2013, and it is expedient to provide an Ordinance for the examination leading to the **BACHELOR OF ENGINEERING DEGREE** the Management Council is hereby pleased to make the following Ordinance.

UNDER FACULTY OF ENGINEERING & TECHNOLOGY

O.E. 1

No candidate shall be admitted to the course leading to Degree of Bachelor of Engineering unless he / she has fulfilled all eligibility conditions as laid down by the Directorate of Technical Education, Govt. of Maharashtra from time to time.

O.E. 2

(A) A candidate to be eligible to pass examinations shall appear and obtain minimum 45% aggregate marks on the basis of part I and II of each examination as under.

First Examination of Engineering	-	Part I & Part II examination
Second Examination of Engineering	-	Part I & Part II examination
Third Examination of Engineering	-	Part I & Part II examination
Bachelor of Engineering Examination	-	Part I & Part II examination

(B) A candidate to be eligible for the award of degree of Bachelor of Engineering will be required to pass examinations as under

First Examination of Engineering	-	Part I & Part II examination
Second Examination of Engineering	-	Part I & Part II examination
Third Examination of Engineering	-	Part I & Part II examination
Bachelor of Engineering Examination	-	Part I & Part II examination

O.E. 3

The class should be awarded to the candidate on the basis of aggregate marks obtained by him / her in Bachelor of Engineering Examination. The award of class shall be as follows-

(A) Aggregate 66 % or more marks	First Class with Distinction
(B) Aggregate 60 % or more marks but less than 66 %	First Class
(C) Aggregate 55 % or more marks but less than 60 %	Higher Second Class
(D) Aggregate 50 % or more marks but less than 55 %	Second Class
(E) Aggregate 45 % or more marks but less than 50 %	Pass Class

O.E. 4

No candidate will be admitted to any examination unless he / she keeps term at a college affiliated to University and produces from the Principal of the college, testimonials of :

- (A) Satisfactory attendance at the theory, practical & term work classes as prescribed.
- (B) Satisfactory completion of the term work prescribed for the part and passing in the term work by securing at least 40 % marks out of the maximum prescribed for the entire term work.

O.E. 5

- (A) A candidate who fails at his / her F.E. Part I examination will be allowed to keep term for his/her F.E. Part II examination, for part wise courses.
- (B) A candidate who fails at his / her S.E. Part I examination will be allowed to keep term for his/her S.E. Part II examination, for part wise courses
- (C) A candidate who fails at his / her T.E. Part I examination will be allowed to keep term for his/her T.E. Part II examination, for part wise courses
- (D) A candidate who fails at his B.E. Part I examination will be allowed to keep term for his/her B.E. Part II examination, for part wise courses.

O.E. 6

- a.1. A candidate who fails in not more than three heads of passing excluding aggregate at F.E. course examination will be permitted to keep term at higher class namely S.E. course examination
- a.2. A candidate who fails in more than three heads of passing excluding aggregate at F.E. Course examination in accordance with O.E. 6. a.1 will not be permitted to keep terms in the higher class namely S.E. course examination.
- b.1. A candidate who fails in not more than four heads of passing including aggregate(of theory and POE and/or OE taken together) subject to maximum three heads of theory examination at S.E. course examination will be permitted to keep term at higher class namely T.E. course examination.
- b.2. A candidate who fails in more than four heads of passing including aggregate at S.E. course examination in accordance with O.E.6.b.1 will not be permitted to keep terms in higher class namely T.E. course examination
- c.1. A candidate who fails in not more than four heads of passing including aggregate (of theory and POE and/or OE taken together) subject to maximum three heads of theory examination at T.E. course examination will be permitted to keep term at higher class namely B.E. course examination.
- c.2. A candidate who fails in more than four heads of passing including aggregate at T.E. course examination in accordance with O.E.6.c.1 will not be permitted to keep terms in higher class namely B.E. course examination.

O.E. 7

- a.** No candidate will be admitted to the S.E. Part I course unless he / she
- i) Passes his/her F.E. Part I & Part II examination
- OR
- ii) Fulfils criteria to keep the term for S.E. Part I examination in accordance with O.E.6.a.1 above
- b.** No candidate will be admitted to the T.E. Part I course unless he / she
- i) Passes his/her S.E. Part I & Part II examination
- OR
- ii) Fulfils criteria to keep the term for T.E. Part I examination in accordance with O.E.6.b. 1 above
- c.** No candidate will be admitted to the B.E. Part I course unless he / she
- i) Passes his/her T.E. Part I & Part II examination
- OR
- ii) Fulfils criteria to keep the term for B.E. part I examination in accordance with O.E.6.c.1 above

O.E. 8

A candidate passing in the minimum prescribed period of final diploma examination of the Board of Technical Examination, Maharashtra State or any other examination held equivalent to the Final Diploma Examination of B.T.E.M.S. is eligible for the admission to S.E. Part I.
