Entry levels into the course, eligibility criteria, admission authority and procedures will be as per the rules of The Government of Maharashtra Directive / The Director of Technical Education, prevailing at the time of admissions.

Entry levels into the course will be at the beginning of the Semester-I or at the beginning of the Semester-III

O B. Pharm – 1.1

Admission authority and procedure at the entry levels into the course

As per The Government of Maharashtra Directive / Director of Technical Education prevailing at the time of admissions.

O B. Pharm - 1.2

Continuation into the subsequent years of B. Pharm course

The admitting authority will be the individual institute where the candidate has been admitted into the course.

a) Eligibility Criteria for Admission to Second Year B. Pharmacy:

Passed his/her First Year B. Pharmacy Examination (Semester-I & Semester-II) OR A.T.K.T.

b) Eligibility Criteria for Admission to Third Year B. Pharmacy:

Passed his/her Second Year B. Pharmacy Examination (Semester-III & Semester-IV) OR A.T.K.T.

c) Eligibility Criteria for Admission to Final Year B. Pharmacy:

Passed his/her Third Year B. Pharmacy Examination (Semester-V & Semester-VI) OR A.T.K.T.

Examination

O B. Pharm – 2.1 For The Award of B. Pharm Degree the candidate is required to pass the following examinations:-

First Year B. Pharmacy Examination (Semester-I & Semester-II) Second Year B. Pharmacy Examination(Semester-III & Semester-IV) Third Year B. Pharmacy Examination (Semester-V & Semester-VI) Final Year B. Pharmacy Examination (Semester-VII & Semester-VIII) And required to undergo a training for a period of at least four weeks in a Pharmaceutical Industry or Govt. Hospital or any Multi Specialty

Hospital of at least 50 bed capacity or community Pharmacy enlisted by the University. The head of the institution shall send to the university, the list of the candidates who have satisfactorily completed the training for the award of degree.

O B. Pharm – 2.2 Semester Examination conducting authority: Solapur University, Solapur.

O B. Pharm – 2.3 No candidate will be admitted to any examination unless he/she keeps term at a College affiliated to the University and produces following testimonials from the Principal of the College:

Attendance of 75% of the prescribed hours in Theory & 80% of the prescribed hours in Practical classes.

O B. Pharm – 2.4 A.T.K.T. rules:

- a) A candidate failing in Semester-I, III, V &VII shall be promoted to next higher semester i.e. II, IV, VI and VIII respectively.
- b) A candidate failing in not more than three theory and two practical subjects of semester I & II taken together shall be promoted to semester-III.
- c) A candidate failing in not more than three theory and two practical subjects of semester III & IV taken together shall be promoted to semester-V provided he has cleared all the subjects of semester-I & II.
- d) A candidate failing in not more than three theory and two practical subjects of semester V & VI taken together shall be promoted to Semester VII provided he has cleared all the subjects of semester-I to IV.

Candidate who has ATKT shall appear for examination in only those subjects in which the candidate has failed.

A Candidate who has obtained less than 50% of the aggregate marks shall be promoted to next higher class subject to above rules of A.T.K.T. Such a candidate shall be allowed to appear in not more than three theory & two practical subjects for obtaining over all 50% marks to pass the examination.

O B. Pharm – 2.5 Sessional Examination.

Conducting authority: College affiliated to the University.

O B. Pharm - 2.6

The sessional examination shall be for 20% of the marks allotted for the subject. The result shall be submitted to the university.

Number of tests: One sessional examination as per the examination scheme (Annexure- I), for each semester.

Time Schedule: The sessional examination shall be conducted normally after completion of at least half the period of semester.

A candidate who has failed in the University examination shall be allowed to appear for improvement sessional examination of the respective subjects in addition to university examination.

Examination of the subject head "Project" shall be conducted by the institute for 50 marks. The result shall be submitted to the university.

Marks, Criteria for passing and other conditions.

O B. Pharm - 2.7.1

Passing criteria for each subject head:

Maximum marks for each subject head and minimum for passing the each subject head (Annexure – I)

Candidate shall be considered as passed in the subject when the candidate fulfils the following two criteria considered together.

- 1) Has got Minimum 40% marks prescribed for each subject and
- 2) Has got Minimum 50% marks in aggregate out of the total marks prescribed for the semester (Annexure I).

O B. Pharm – 2.7.2 Pa

Passing of the semester.

Candidate will be considered as passed the semester only when the candidate passes in all the subjects and obtains overall a minimum of 50% of the aggregate marks prescribed for the semester (Annexure - I).

O B. Pharm - 2.8

Award of the degree and Class.

Degree shall be awarded to the candidates who have passed all the eight semesters.

The class shall be awarded on the basis of the combined marks at the semester VII & semester VIII as per the details given below
