1. Case:

In 2006-07 PTC Food Division decided to enter the fast growing (20-30% annually) snacks segment, an altogether new to it. It had only on national competitor – Trepscio's Trito. After a year its wafer snack brand Ringo, fetched 20% market share across the country. Ringo's introduction was coincided with the cricket world cup. The wafer snacks market is estimated to be around Rs. 250 Crores.

The company would take the advantage of its existing distribution network and also source potatoes from farmers easily. Before the PTC could enter the market a cross-functional team made a customer survey through a marketing research group in 14 cities of the country to know about the snacks of eating habits of people. The result showed that the customers within the age group of 15-24 years were the most promising for the product as they were quite enthusiastic about experimenting new snack taste. The company reported to its chefs and the chefs came out with 16 flavors with varying tastes suiting to the targeted age – group.

The company decided to target the youngsters as primary target on the assumption that once they are lured in, it was easier to reach the whole family.

Advertising in this category was extremely crowded. Every week two-three local products in new names were launched, sometimes with similar names. To break through this clutter the company decided to bank upon humor appeal.

The Industry sources reveal that PTC spent about Rs. 50 Crores on advertisement and used all possible media print and electronic, both including the creation of its own website, Ringoringowingo.com with offers of online games, contests etc. mobile phone tone downloading was planned which proved very effective among teenagers. The site was advertised on all dotcom networks.Em TV, Bee TV and other important channels were also used for its advertisement along with FM radio channels in about 60 cities with large hoardings at strategic places.

Analysts believe that Ringo's success story owes a lot to PTC's widespread distribution channels and aggressive advertisements. Humour appeal was a big success. The 'Ringo' was made visible by painting the Railway bogies passing across the states. It has also been successful to induce Lovely Brothers' Future Group to replace Trito in their big Bazaar and chain of food Bazaars. PTC is paying 4% higher margin than Trepsico to Future Group and other retailers.

Ringo to giving Trepsico a run for its money. Trito's share has already been reduced considerably. Retail tie-ups regional flavours, regional humor appeals have helped PTC. But PTC still wants a bigger share in the market and in foreign markets also, if possible.

Most businesses have to consider the impact of their activities on stakeholders. Coca-Cola is no exception but their operations in the southern Indian state of Kerala have caused widespread concern and a string of claim and counterclaim by residents of the local community and the company.

In 1998 Coca-Cola set up a bottling plant in Perumatti in the southern state of Kerala. Since it opened, local villagers have complained about the fall in the amount of water available to them and have blamed the fall in supplies on Coca-Cola who, they claim, use upto a million litres per day at the plant. Coca-Cola claims that the shortage in the water is due to the lack of rains in the region. Coca-Cola even sends round tankers of water to the region to help the local community. Local farmers are claiming that their livelihood has been destroyed since the building of the plant and that the number of people working on the land has dropped considerably because they cannot survive.

Coca-Cola has become one of the most popular drinks in India. Following the cleaning of the bottles, a waste sludge is produced that Coca-Cola have been disposing off on the land of the local farmers claiming it was a useful fertilizer. Following a BBC Radio 4 programme, samples of the sludge were analyzed by scientists at Exeter University in the South West of England and found to contain toxic chemicals including lead and cadmium- both of which can be harmful to humans and further suggested that there was little or no benefit of the sludge as a fertilizer. Recent tests by the local state laboratories found that the levels of toxic chemicals is within safety levels but that it should not be used as a fertilizer.

In a separate development, sales of Coca-Cola have been hit by suggestions that its drinks produced in India contained higher levels of pesticide residues than was healthy ! A large number of bodies have joined in the campaign for the local community demanding the plant be closed down and that tests be carried out on Coca-Cola to assess its safety. A lawsuit to this effect was thrown out in August which prompted Coca-Cola to issue an angry comment claiming that the reports were scurrilous, unnecessarily scared large numbers of Coca-Cola's customers and put thousands of jobs in its plants throughout India at risk. 1. Analyse the case :

Trans India Freight Services Pvt. Ltd., is an Indian arm of Allcargo Global Logistics and has designed on 40 foot equivalent unit high-cube containers for transportation of cars. These containers will be moved primarily on rails. Currently around 98 per cent of cars' transport operations are carried on by roadways and the remaining is by railways. The rod sector for car transport is highly fragmented. When carrying automobiles on road the speed of the carrier is 20-40 km/hr and they do not travel at night. For example, Delhi to Mumbai takes six to nine days, which results in holding up of an inventory. The high-multiple handling results into 10 per cent of the cars getting damaged during transportation. With the new logistical packaging for car transportation on rail there will be significant reduction in-transit times and in-transit damages to the cars. In the beginning the cost of transportation will be comparable to road transportation. However, with full-fledged operation, the cost will go down by 5 per cent and with double stacking the cost reduction will be 20 per cent. In the new packaging system, the cars are placed on to 'trans-rak', which is a simple, fixed-frame system. It is fitted into 20 ft., 40 ft., 45 ft., 53 ft. and pallet wide ISO containers ensuring safe, simple and secure transportation of vehicles in containers. It ensures total security in shipping cars directly from the factory to arrive in perfect condition inside and out at destination. The trans-rak are free from theft, dirt and weathering; no knocks, dents or scratches; no road, rail, roro or quayside handling, simple to operate for

containerizing the cars with no special skills. Trans-rak adjusts for all car shapes and are lifted and lowered with a hand-held drill. This was not the first attempt to carry automobiles by rail. Indian Railways has tried it earlier. A few passenger trains were converted into car carriers. However, the venture was financially unviable because carriers did not get returned load. The success of this packaged transportation depends on the rail infrastructure with dedicated freight corridors.

1. Case Study.

Royal Engineering designs, develops, manufactures and sells high-quality specialized electronic goods using technology that has been created in-house. Approximately 60 per cent of the company's operating revenue is derived from export markets. The company is a 'first-mover' in its field; it is not an imitator. Given its small size relative to other global firms, Royal has adopted a niche strategy, marketing to certain groups interested in the unique products it offers.

Because of the company's commitment to innovation, management has placed strategic importance on the employment of R & D engineers as the drivers of new products. Speed to market is vital to ensure that the firm would be the first to release new products. R & D engineers are vital in this process. There are 57 engineers out of the total of 520 employees. They are much in demand by competitors but because of the interesting work and career prospects, labour turnover is not too high-last year six of them left. The company is expanding steadily and recruits three or four engineers straight from university every year but relies quite extensively on external recruitment to obtain more experienced people. Five qualified engineers have been recruited in the last six months and at present there are four unfilled vacancies.

However, the Director of Engineering is not satisfied with the quality of the new recruits. They are not up to the standards expected and are not setting down. He has left final selection to his three departmental heads, although the head of HR (who reports to the Managing Director) has been responsible for the initial recruiting process and submitting candidates to the departmental heads, who draw up shortlists and conduct interviews.

The Director of Engineering called in the Head of HR to explain why this situation had arisen. The latter used the excuses that good engineers were difficult to find and that the departmental managers had made poor selections. He had been present at some interviews, although, because he was not an engineer, he had not taken an active part. He had observed that they were distinctly lacking in interviewing skills, having no idea how to structure an interview and were prone to making subjective judgements based on personal prejudices. He was thinking about what should be done about it but had not got around to taking any action yet. The Director of Engineering would have none of this. He said in no uncertain terms that this was the Head of HR's responsibility. He couldn't just 'sit in' and observe. He couldn't just 'sit back' and let events take their course. This was gross dereliction of duty. He had to do something about it and fast. If the departmental heads were not good at selecting people, it was up to him (the Head of HR) to ensure that they improved significantly. The achievement of the business goals of the company depended on getting and keeping good engineers.

Somewhat chastened, the Head of HR retreated to consider what he should do. He had to admit to himself that he had left it mainly to the specialists and he knew that his future with the company was in danger if he didn't deliver the goods – the Director of Engineering was the key player in the firm and would have no difficulty in convincing the Managing Director that the Head of HR wasn't up to the job. The Head of HR had to reach conclusions on what approach to the selection of engineers should be adopted and what he should do about the departmental managers' interviewing skills.

The Farmers

Tony de Castro has perfected the technique of worm composting. Under the humid tropical climate earthworms eat up industrial quantities of solid organic waste. The result is black humus after only six weeks, which is the perfect medium to enrich soil for organic agriculture. Tony has thus started market gardening of vegetables to make use of the ten tonnes of vermin compost he produces every month. After investing in a 6 ha vegetable farm, he has contracted with five farmers, including four very poor landless farmers, with a total area of 5 ha and trained them in using vermin compost. As a result he has found himself at the head of a small group of organic vegetable producers with three tonnes of produce in need of a market every week.

The market

Tony and his group supply the biggest vegetable category manager for the largest retailing chain in the Philippines. The chain would like Tony to deliver organic vegetables for its twelve outlets but the group can only produce enough vegetables for three outlets. Tony and his group thus have an expanding national market to continue developing production of their vermin compost and their organic vegetables.

The linkages

Tony is also the marketing outlet for the farmers. He purchases all the produce grown by them. Purchase orders are sent to Tony on his mobile phone by SMS. Tony buys the produce at 50 to 70 percent of his own sales price, depending on the product. Therefore, the producers have an assured market and a fixed price for their produce. Tony only rejects items that are under-sized or of awkward shape. A few holes in leafy vegetables are actually a visible sign of an organic produce for discerning consumers. Tony also has his own direct marketing outlet in Metro Manila.

Cultural barriers is one of the most talked about in international business problems. It is, however, very interesting to note that cross-border transmission of culture is very rampant. Many politicians, sociologists and others are highly critical of the invasion of the Western culture in the developing countries. The export of American culture is interpreted as means to spread American imperialism. The Coca Cola culture or the corn flakes culture or the pop culture, the term which has come to be very broadly used to include, besides the pop music and associated thing, the Western products and styles such as foreign jeans, cola drinks, fast foods, Hollywood movies and like the youth, particularly, are crazy about, has fast spread to the developed and developing countries. The emergence of culture as economic goods that can be traded-crafts, music, films, TV programmes, software, books, tourism etc.-has contributed very substantially to the globalization of culture.

A UNESCO study shows that world trade in goods with cultural content-printed matter, literature, music, visual arts, cinema and photographic, radio and television equipment-has grown tremendously. For the United States the largest single export industry is fllot aircraft, computers or automobiles-it is entertainment, in films and television programmes. Hollywood films grossed more than \$30 billion worldwide in 1997, and in 1998 a single movie, *Titanic*, grossed more than \$1.8 billion. As the *Human Development Report* 1999 points out, the vehicles for this trade in cultural goods are the new technologies. Satellite communications technology from the mid-1980s gave rise to a powerful new medium with a global reach and to such global media networks as CNN. The development of the Internet is also spreading culture around the world, over an expanded telecommunications infrastructure of fiber optics and parabolic antennas.

The Report referred to above points out that the global market for cultural products is becoming concentrated, driving out small and local industries. At the core of the entertainment industry-film, music and television-there is a growing dominance of US products, and many countries are seeing their local industries wither. Although India makes the most films each year, Hollywood reaches every market, getting more than 50 per cent of its revenues from overseas, up from just 30 per cent in 1980. It claimed 70 per cent of the film market in Europe in 1996, up from 56 per cent in 1987 and 83 per cent in Latin America and 50 per cent in Japan. By contrast, foreign films rarely make it big in the United States, taking less than three per cent of the market there. In the light of the above account, evaluate the view that culture is a highly difficult barrier to international business. What are the implications of the spread of pop culture for business ? More than measuring up to Indian standards :

Shaw Moisture Meters has a long and illustrious history of exporting to India where its ultra precision instruments have long been prized for their quality. It began exporting to India 30 years ago and the country remains one of its top six worldwide markets.

The firm, whose dew point meters measure in parts per billion, was originally set up to test the moisture content of wool in the Yorkshire textile industry in the immediate post-war years. Since then, Shaw Moisture Meters has specialized in measuring trace moisture in gases and compressed air and its products have found applications in numerous industries. In India the firm sells too many industrial companies including compressed air, electronics manufacture and power generation applications. The company operates in India using a long-standing representative, although managing director Tim Peters has regular contact with both the representative and end customers to maintain all-important relationships. He stresses the importance of keeping those on the ground up to date with as much information and support as possible to retain close ties with customers.

"It's a growth market and we are seeing increasing levels of business," he says. "We have a strong presence there and it's improving. We have a massive plus in India because of our pedigree. "Our history of being an established British manufacturing company stands us in good stead. Our reputation for a quality product and excellent levels of service is complemented by being in business for 60 years".

As many other exporters have discovered, having close ties with those whom you deal with is all important in India – and very different from doing business in European countries.

1. Analyse the case.

Prescription drugs are drugs that can be obtained by a patient only with or under the orders of a physician. The reason for the restriction is that the drugs contain side effects, are not considered safe for casual use, and should be taken under a doctor's supervision. Some such drugs, after many years of safe use with few side effects, are allowed to become over-the-counter drugs and can be purchased and used with a doctor's prescription.

In the United States, until 1985, prescription drugs could not be advertised directly to consumers. That year the U.S. Food and Drug Administration (FDA), which has responsibility for safety regulations governing drugs, passed a ruling that allowed direct market to consumers on the condition that a great deal of warning information was provided about side effects and other dangers. This allowed for advertising the drugs in magazines, for instance, in which the manufacturer could include the necessary information in small print on several pages following the main part of the ad for the product in question. The large amount of information that had to be supplied, or not it was read, precluded any direct TV advertising of drugs. That changed in 1997 when the FDA ruled that TV ads containing just the major dangers of the drug were permissible. The result was a deluge of direct-to-consumer TV ads for prescription drugs. One study showed that for each dollar of direct-to-consumer advertising on TV by the pharmaceutical company during 1999-2000 resulted in a return of \$4.20 for each dollar spent. In 2005, the pharmaceutical spent \$1.19 billion on TV ads.

The United States and New Zealand are the only two developed nations that allow direct-to-consumer advertising of pharmaceutical drugs. Why are nations and people divided on the appropriateness of direct-to-consumer pharmaceutical drug

advertising? The drug industry claims that such advertising benefits consumers in a variety of ways. It educates them about a variety of illnesses and informs them of possible drugs to treat them. It thus encourages people to contact their doctors if they have the symptoms described, and facilitates an open conversation between them. Informed patients are better able to pursue their health care options than uninformed ones. Seeing the ads on TV increases their trust in them when they are prescribed by their doctors, and simple name recognition makes the drugs more acceptable. In the end, it is the doctors who are the gatekeepers and must prescribe or withhold prescriptions. Hence, the good achieved outweighs any bad that might result.

Opponents, however, reply with reasons and concerns of their own. It is because drugs have potentially serious side effects that they require a doctor's prescription. As such it should be upto the doctor to decide on and prescribe what he or she deems appropriate and best for each individual patient. Broadcast advertising creates false impressions about effectiveness and downplays possible adverse effects. Such advertising leads to self-diagnosis. Patients pressure their doctors for the drugs advertised, whether they are the best for their treatment or the most cost effective. Often a variety of drugs are available for a given condition-such as for high blood pressure. Doctors can choose from among the large variety available. The newer ones are the ones advertised and are usually among the more expensive. They are not necessarily more effective than older and less expensive ones. Yet, since they are acceptable, doctors often yield to the patient's pressure or choice, even though it is not a well-informed choice. TV ads do not claim the advertised drugs to be the best or that they are a certain percent more effective than older drugs, nor do they compare the cost of the advertised drug with available generic drugs of the same class. Even though a patient's health insurance may pay for the more expensive drug when a less expensive one would do as well, the cost of prescription drug insurance goes up for all. The cost of the ads, moreover, drives the cost of drugs even higher. The claimed educational value of the ads, is not the real reason for the industry's spending all it does on ads. The real reason is the increase in purchases of the new drugs. Yet, if they were as good as advertised, they would be adopted and prescribed by doctors without the direct-to-consumer ads and the industry could spend its money on truly educational TV ads. The calculation made by the critics yields more harm than benefit from such ads and hence many hold them not only inappropriate but unethical. Based on this reaction, a large number of bills have been introduced into the U.S. House and Senate and into state legislatures curtailing the direct-to-consumer pharmaceutical drug ads on TV. Some have passed on the state level.

1. Analyse the Case.

The Apple product life cycles indicates just how big the iPhone and the iPad will be over the next few years. It took the iPod five years to break the thirty million units per annum mark. The iPhone got there in four and the iPad will make it in year two of launch. As for the Sony Walkman it never made it, it took over ten years to top out, the iPod topped out within eight years of launch. Apple product Life Cycles are moving faster and higher sooner than ever before.

iPod sales may have peaked in 2008 at just under 55 million units and may fall to around 45 million units this year but the iPhone is set to sell just under 70 million units and the iPad is chasing fast behind. It all adds up to an exciting phase of growth for Apple over the next four years with revenues set to rise over \$ 100 billion in 2011.

Students of corporate strategy and business theory are familiar with the concept of the Product Life Cycle. Generally the life cycle is perceived to have four specific stages, introduction, growth, maturity and decline generally plotted with volumes a function of time.

In the introduction phase, costs are high, sales volumes are slow, there may be little or no competition and customers have to be stimulated to action. Profits are limited and the product is cash extensive as marketing costs are substantial. Key customers tend to be innovators and early adopters.

In the growth phase, unit costs are reduced as volumes increase, advertising is amortised over greater volume, market awareness increases beyond the early adopters, to the "early majority", competition increases with more competitors entering the market and price levels may begin to fall. Profits increase but the product remains cash extensive as greater investment in marketing or working capital is required.

In the maturity stage, costs are lowered further as volumes have increased, the market becomes more competitive and alternative products begin to date the initial product offering. The product remains profitable and begins to generate cash. The innovators, early adopters and early majority are joined by the "late majority".

In the saturation and decline phase, sales volumes decline, profits margins are maintained and the product becomes remains cash generative. The laggards and luddites still do not enter the market.

Either way for Apple, four years of strong growth are evident from products already in the lineup, both the iPhone and the iPad are set to hit the one hundred million units per annum mark in 2012 and 2014. Despite the march of the Androids, the Apple growth story will continue.

1. Analyse the case :

Trans India Freight Services Pvt. Ltd., is an Indian arm of Allcargo Global Logistics and has designed on 40 foot equivalent unit high-cube containers for transportation of cars. These containers will be moved primarily on rails. Currently around 98 per cent of cars' transport operations are carried on by roadways and the remaining is by railways. The rod sector for car transport is highly fragmented. When carrying automobiles on road the speed of the carrier is 20-40 km/hr and they do not travel at night. For example, Delhi to Mumbai takes six to nine days, which results in holding up of an inventory. The high-multiple handling results into 10 per cent of the cars getting damaged during transportation. With the new logistical packaging for car transportation on rail there will be significant reduction in-transit times and in-transit damages to the cars. In the beginning the cost of transportation will be comparable to road transportation. However, with full-fledged operation, the cost will go down by 5 per cent and with double stacking the cost reduction will be 20 per cent. In the new packaging system, the cars are placed on to 'trans-rak', which is a simple, fixed-frame system. It is fitted into 20 ft., 40 ft., 45 ft., 53 ft. and pallet wide ISO containers ensuring safe, simple and secure transportation of vehicles in containers. It ensures total security in shipping cars directly from the factory to arrive in perfect condition inside and out at destination. The trans-rak are free from theft, dirt and weathering; no knocks, dents or scratches; no road, rail, roro or quayside handling, simple to operate for

containerizing the cars with no special skills. Trans-rak adjusts for all car shapes and are lifted and lowered with a hand-held drill. This was not the first attempt to carry automobiles by rail. Indian Railways has tried it earlier. A few passenger trains were converted into car carriers. However, the venture was financially unviable because carriers did not get returned load. The success of this packaged transportation depends on the rail infrastructure with dedicated freight corridors.

1. Case Study :

The farmers :

The Mango Farmers' Association and The Union of Farmer Groups in Java, Indonesia, worked with a mango exporter to supply mangoes to international markets. The majority of mango farmers in the Association were large farmers and some of them also worked as fruit traders. In contrast, the Union of Farmer Groups gathered small-scale farmers, some of whom were also informal village leaders. The exporter was still a new player in the mango business but already had lots of experience in importing fruits.

The market :

Mangoes were exported through distributors to Middle Eastern countries.

The linkages :

Before the intervention, the farmers had not been selling mangoes directly to an exporter. However, some of the larger farmers had been exporting mangoes through large traders in their village. The formation of mango supply chains direct to the exporter was mediated by the local governments who also acted as controllers of these relationships. The exporter hired a local manager to assist farmers to meet the export requirements, administer prices for various mango qualities and also reject products of too low quality.

The results :

After only one mango season, the supply chains collapsed and the exporter decided not to continue the relationships. Only a few mangoes had been supplied to the exporter and some mangoes had been returned by the exporter due to their low quality. The following factors contributed to this failure.

• Exclusion of local traders : The farmers' decision to sell mangoes to the exporter was conditioned by comparing benefits of this new type of supply chain and the traditional one.

The new supply chains, however, attempted to exclude the traders and this increased the level of resistance. The traders have had significant roles in sustaining the traditional supply chains through the provision of financial assistance to farmers, coordination of suppliers and buyers, accumulating produce and transportation to the central locations, taking market risks and adding value to product through grading process. They had set up flexible systems to maintain their capacity to respond to market disruptions by managing inventory and picking the fruits directly from farmers using their own transportation, and accepting various quality of mangoes. Hence, the traders' strategies made the supply chains more resilient compared to the new mango supply chains. The latter applied practices which were different to those practices particularly in financing, distributing and product requirements.

- The supply chain was set-up with unrealistic supply and sales targets for the farmers which was based on false and insufficient information on supply and market. The exporter and the mango group leaders assumed that the farmers could meet the supply target. They expected many farmers would be interested is being involved in the supply chains. In fact, only a small percentage of mango farmers supplied to the exporter. Also, the exporter and the group leaders failed to consider to the resistance of other players (traders).
- Some farmer groups tried to supply the exporter with lower quality of mangoes. The farmer group leaders took a benefit for themselves by acting as traders for their own group and modified a quality rule to meet the target of mango supply particularly at peak mango season.

Linkages failed with both the Farmer Association and the Union of Farmer Groups. However, the latter could learn better from the failure. They were still working in a group to market their mango after the chain collapsed. The group leaders acted as traders for the groups.

In 1994, with a handful of programmers and a few thousand dollars in workstations and servers, Jeff set out to change the retail world when he created ABC com. In July 1995, ABC opened its Website for sales. Using heavily discounted book prices (20 to 30 percent below common retail prices); ABC advertised heavily and became the leading celebrity of the Internet and e-commerce.

ABC made its initial mark selling books, and many people still think of the company in terms of books. However, almost from the start, the company has worked to expand into additional areas striving to become a global retailer of almost anything. Some of the main events include: 1995 books, 1998 music and DVD/video, 1999 auctions, electronics, toys, zShops/MarketPalce, home improvement, software, and video games [1999 annual report].

By the end of 1999, the company had forged partnerships with several other online stores, including Ashford.com, Audible, Della.com, drugstore.com, Gear.com, Green-light.com, HomeGrocer.com, Kozmo.com, living.com., NextCard.com, Pets.com, and Sothebys. Ofcourse, most of those firms and Web sites later died in the dot-com crash of 2000/2001.

ABC also established partnerships with several large retailers, including Target, Toys 'R' Us, Babies 'R' Us, and Circuit City. Effectively, ABC became a service organization to manage the online presence of these large retailers. However, it also uses its distribution system to deliver the products. The Circuit City arrangement was slightly different from the others – customers could pick up their items directly from their local stores. After Circuit City went under, the relationship ended.

By mid-2003, the Web sales and fulfillment services amounted to 20 percent of ABC's sales. Bezos points out that most companies realize that only a small fraction of their total sales (5 to 10 percent) will come from online systems, so it makes sense to have ABC's run those portions.

In 2001, ABC took over the Web site run by its bricks-and-mortar rival Borders. In 2000, Borders lost \$18.4 million on total online sales of \$27.4 million. Also in 2001, ABC partnered with Expedia to offer travel services directly from the ABC site. However, in this case, the ABC portion consists of little more than an advertising link to the Expedia services. The deals in 2001 continued with a twist when ABC licensed its search technology to AOL. AOL invested \$100 million in ABC and paid an undisclosed license fee to use the search-and-personalization service on Shop@AOL. In 2003, ABC launched a subsidiary just to sell its Websales and fulfillment technology to other firms. Bezos noted that ABC spends about \$200 million a year on information technology (a total of \$900 million to mid-2003). The purpose of the subsidiary is to help recover some of those costs – although Bezos believes they were critically necessary expenditures.

In 2008, Sanlu, a Chinese dairy farm was accused of producing melamine contaminated milk. After drinking this milk formulation, nearly 53,000 infants across the country were affected with 13,000 infants immediately hospitalized. Negligence of the company, lack of proper food safety measures and cut-throat competition within the industry were some of the factors which led to such a scandal. The company was badly affected as a result. Sanlu was driven into a huge financial crisis and ultimately became bankrupt. To save the company, the Chinese government invited other companies to acquire Sanlu. Finally, Sanyuan Food Co. agreed to acquire it. The Chinese government launched a thorough in-depth investigation to find out the actual cause behind the scandal. Stringent quality check measures were adopted by the government. Investigators were instructed to check each and every batch of milk produced in the dairy farms.

These measures finally helped the government to ensure that contamination free milk was produced after 14 September 2008. Although the Chinese government was able to stop the further spread of the contamination, the future of Sanlu remained doubtful. Critics were sceptical about Sanlu's ability to regain its lost status and goodwill in the industry.

Walt Disney Company (Disney) is an entertainment conglomerate operating in different business sectors such as media networks, parks and resorts, studio entertainment and consumer products, across the world. Disney is present in a large number of countries in Europe, Asia and Latin America apart from America. Disney was the result of one man's ability to dream big. With barely US \$40 in his pocket, Walter Elias Disney (Walter) dreamt of making great Hollywood movies one day. In 1923, he started Disney Company. He also began production operations for films along with his brother. In 1928, Walter created the lovable 'Mickey Mouse' character for a silent cartoon film called 'Plane Crazy'. And there was no looking back after that. The company went on to create and market in various forms several other much-loved characters that proved extremely popular with children and adults alike. Walter's greatest dream was to provide fun for children and their families. This dream came true in 1955, when Disneyland was launched as a large theme park' in California. Disney used the characters created by it and their images to encourage people to have fun in the park. In April 2001, Ramoji Group's Film City, hosted its first English production, 'Quicksand', produced by Ramoji Rao and directed by Sam Firstenberg. Thus, Ramoji Film City brought international (Hollywood) attention to Hyderabad. Ramoji Rao incorporated the Ramoji Group in 1962, with Margadarsi Chit Fund Ltd. By 2001, the Rs. 15 billion Ramoji Group became one of the biggest business houses in India to expand into the media (print and broadcast), entertainment, foods, films and other industries. The group had interests in newspapers and magazines, hotels, films and television, investment companies, condiments and confectioneries, a 1000-acre film city, apparels and handicrafts.

Over the years, the Ramoji Group under the entrepreneurship of Ramoji Rao, seemed to have set standards in the print, television and the film industry. Analysts felt that Ramoji Rao's excellent business acumen, sharp insight and an eye for spotting out opportunities, made him a successful entrepreneur. Ramoji Rao, started his career in the early 1960s in Delhi with an advertisement agency – Ad Crafts. In 1962, he opened the first branch of Margadarsi – a chit fund company in Hyderabad. Realizing the advertising needs of Margadarsi, Ramoji Rao established an ad agency – Kiron Ads – named after his eldest son.

Kiron Ads was the first accredited ad agency in Hyderabad. After a few years, the second branch of Margadarsi was opened in Visakhapatnam. This was followed by the setting up of Dolphin Hotel in Visakhapatnam. The Hyderabad edition was launched in 1975, followed by the Vijayawada edition in 1976. In the early 1980s, Ramoji Group entered the foods business with Priya Pickles. The Priya brand was later extended to culinary pastes and powders. The Group then made a foray into films with Ushakiron Movies.

The Group established Mayuri Film Distributors to distribute its films and Mayuri Audio to market the audio cassettes of the films. In the early 1990s, Ushakiron Movies diversified into satellite television with ETV – the Telugu channel. In 1992, the Ramoji Group started a handicrafts division under the name 'Kalanjali'. The division was set up with a view to promote the sale and export of handicrafts, cottons and textiles of Indian craftsmen.

On September 9, 1997, the Ramoji Group inaugurated its most innovative creation – The Ramoji Film City based on the maxion. Walk in with your script and walk out with your print. Spread over 1000 acres, the Film City had gardens, temples a sprawling countryside, a fort, hotels, city streets, railway stations, a palace, an airport, a mobile kitchen etc. It had all the technical support to make a film – 40 studio floors, a fully – equipped prop shop, a set design and construction division, state-of-the-art equipment, experienced production staff and hi-tech digital editing, dubbing and sound-recording facility. The idea is to save time, energy and resources and focus on creative excellence, executional quality, economical schedules and meticulous planning.

Ramoji Rao's biggest coup in the print industry was the introduction of a color, tabloid sized 'mini-edition' of Eenadu for each of the districts in Andhra Pradesh. In 1998, he bagged the B. D. Goenka Award, a prestigious award for excellence in journalism. Some analysts however felt that Ramoji Rao followed 'campaign journalism'. From one company in 1962, the Ramoji Group became a Rs.15 billion business empire with presence in many industries by 2001. For future growth, Ramoji Rao planned to concentrate on the group's core businesses like the print media, satellite television and films. As part of the future plan, Ramoji Rao announced investments in film industry. In 2001, Eenadu TV planned a Rs. 600 million upgradation of its earth station. The project included a Rs. 180 million project to automate its newsroom. The group also planned to launch newspapers in other south Indian languages.

However not all experts were of the same view, Mahesh Murthy, co-founder of Seed fund said, "while this (deal between Flipkart and Myntra) may be good for investors, it might not so good for the entrepreneurs and staff of these companies" Swati Bhagava, cofounder of Cahskro.com, said "Consolidation of top two out of five players is probably not great from a customer perspective. It reduces competition and perhaps incentive for continual improvement.

The online retail space formed about 0.55% of the overall Indian retail industry (about Rs. 25.3 billion) and included organized and unorganized retail. The online retail industry constituted just about 7.9% of the organized retail industry in

India. Indian e-tail industry players mostly followed an inventory based model or a non inventory based model also known as the market place model. In August, 2014, the players which followed the inventory based model were abong.com, Myntra.com, firstcry.com, Zovi.com (all were online retailers) and players that followed in the Non inventory based model were Flipkart.com, Snapdeal.com, ebay.in and Amazon.in (all were marketplaces). Industry experts felt the Flipkart and Myntra deal could start a phase of consolidation in the Indian Online retail space which was worth about Rs. 139 billion (about US# 2.32 billion) in 2012-13.

1. Case Study.

A company was manufacturing heaters in different models with different capacity. A group of 10 workers were engaged n assembling heaters. At one workstation they are assembling parts with the help of tools and then heaters being transferred to another workstation for further process. After completion, inspector used to check for quality and working. Heater used to get packed in different containers.

The assembly line was properly balanced by industrial engineers who had used time and motion study to break jobs in subassembly task. The time required for each subassembly had also been balanced so that the task performed by the each worker was supposed to take exactly the same amount of time. The workers were paid on an hourly basis.

The inspector observed that morale amongst workers was low and there were a percentage of badly assembled heaters. Rejects caused by the worker rather than faulty materials were about 22%. After discussing the issue with management it was decided to have meeting with the workers. The workers were asked whether they would like to build heaters individually. Workers agreed with an option of going back to the old program if the new one did not work well. After several days of training each worker began to assemble entire heater.

The workers were motivated and supported by inspector. Productivity increased remarkably. Rejects caused by workers reduced to only 5% from 22%. Workers have responded positively and their morale was high and the workers did all the routine inspection by themselves. Inspector was posted on another post at other location.

Prakash Chand has been working as Production Assistant since 2001 in Bharat Zinc Limited, Visakhapatnam. Mr. Gangadhar at 4 pm on 15th June 2007 gave a pocket containing semi processed zinc to Mr. Prakash and asked him to deliver it before 5 pm on the same day to Mr. Surjeet, the Laboratory Supervisor of Bharat Heavy Plates and Vessels. Mr. Prakash rushed to Bharat Heavy Plates and Vessels on a two wheeler and delivered the pocket personally to Mr. Surjeet at 4.45 pm on 15th June 2007 and recorded the transaction in the register concerned of both the parties and left the office of Mr. Surjeet.

Mr. Prakash's vehicle foiled on the way and as such he was repairing the vehicle. At the same time there was storm and heavy rain from 5.30 pm to 7.30 pm. Mr. Prakash parked his vehicle one side of the road and rushed to a nearby old house, which housed a liquor shop. The house completely collapsed at around 7 pm. It was found at around 9 pm that all the people including Mr. Prakash died. The family members of Mr. Prakash approached Mr. Gangadhar at 11 am on 16th June and informed him of the event. Then Gangadhar repented of the entire incident and has written a letter to the Human Resource Manager narrating the total incident that took place from 4 pm of 15th June to 11 am of 16th June including the repair of Prakash's vehicle. Mr. Gangadhar in his letter requested the HR Manager to pay compensation to the wife of Mr. Prakash as Mr. Prakash died while performing his duty. The HR Manager, informed Mr. Gangadhar and the wife of Mr. Prakash that the company need not and will not pay compensation as the accident took place outside the working hours of the factory and outside the work place i.e., factory. Mr. Gangadhar and the wife of Mr. Prakash appealed to the CEO to look into the matter and do justice.

The farmers

Forty-seven farmer households growing certified organic asparagus in Srakaew Province are part of a special group of poor smallholders cultivating land belonging to the Royal family. Once farmers on this special site are deemed financially better off than when they joined the group, they are asked to leave the site to join other groups of farmers under contract with Swift. This enables other poor households to enter the group and benefit from its advantages.

The market

Swift Co. Ltd. is the sole outlet for the organic asparagus of the farmer group. Swift supplies fresh, frozen and precut fruits, vegetables and herbs to export customers in the United Kingdom, Japan and the Middle-east. The customers are very demanding; they require produce that is certified as organic according to their country's standards. Swift takes responsibility for the certification and thus pays for several certifications on behalf of the farmers' group.

The linkages

The farmers are given 2 rai (1 rai = 0.16 ha) of land each free of any lease. The land is located on Royal property given out to Swift to implement contract farming of organic asparagus. Swift signed an initial exclusive supply contract with the farmer group in 2002. The company trains these farmers on organic production methods and buys their whole harvest at a fixed price. This price is fixed for the duration of the contract of three years. A second contract was signed in 2005.

Bermuda Import and Export.

Bermuda Import and Export (BIE) is a family-owned import business, started in 1949. Graham Fowle, grandson of the original owner and current company president, gradually expanded company lines, starting with the addition of produce and alcohol. Bermuda Import and Export now has 25 employees and carries produce, seafood, groceries, alcohol, dry and frozen goods and some dairy and meant. The majority of goods are perishable items. Bermuda is a small market of 21 square miles; the company sells to all available outlets, including restaurants, hotels, resorts, clubs, grocery and convenience stores. There are no consumer retail sales. In Bermuda, everything is imported – and nothing comes into the island without some type of import fee/cost. BIE brings in two containers of produce (not including seafood and alcohol) weekly. The containers usually arrive on Sunday night and Monday morning and produce must be pre-cleared through H.M. Customs – Bermuda (Customs) in time for delivery to restaurants, shops and hotels early on Monday morning. This required a deposit to be paid in advance on all pre-cleared items of $1^{1}/_{2}$ times their normal duty rate.

The old system of managing tracking and invoicing of shipments through Customs was time and labor-intensive. It involved a complicated spreadsheet, with manual entry of the details of each individual item. These details included (but were not limited to) vessel information, voyage number, bill of lading, container information, date of arrival, Customs Procedural Codes, tariff numbers, country of origin, purchase order number, wharfage charges (assessed against cargo, vessel's stores, fuel and supplies for passage on, over, under or through any wharf) and vessel details. The process took at least four hours ("if the person knew what he was doing," adds David, wryly), and was fraught with potential errors. For example, a misplaced decimal point could potentially incur thousands of dollars in extra duty costs prior to being recalculated. Because items had various duty percentages (ranging from five to $22^{1/4}$ percentage), calculations were often rounded up or averaged. If the work was not completed on time, it would delay delivery of containers and cause possible damage to goods. Finally, getting the Customs deposit (averaging \$750) returned could take up to a month - after all the double-checking of calculations and adjustments for manual entry errors.

David Potts considered his options, including one island-based company offering a software solution. However, the cost was more than \$20,000 and it would not integrate easily with the firm's existing applications. Having already used Blue Link's accounting software, and very happy with the quotation from Blue Link – David asked the company to devise a custom-built solution. In the midst of Blue Link gathering the necessary information to build the custom application, the Bermuda Customs changed their declaration process. New processes were instituted, including an 'unusual commodities' tariff code used to determine the percentage of duty owing. However, Blue Link made additional changes to the program, pulling in all the additional information to deal with the many intricacies of dealing with the Customs' paperwork. This included the ability to add detailed information, define individual specifications and create a Customs Declaration form from the purchase order.

Because Blue Link set up the entire process at BIE, all items are treated equally and reporting is streamlined. David is happy: "Everything is fine, it works just wonderfully". He explains how the software saves time: "We just check the purchase order against the invoice, make sure there are no discrepancies, verify the bill of lading, and the system crates the Customs Declaration form, the accounting voucher and the cheque amount. It's a three to five minute process, and saves a lot of time". Staff hours, and subsequent employee costs are also reduced: "We had one person doing this process for the whole company and he retired last year - and we've not had to replace him. We've been able to split up the work with no extra workload." Processing the Customs declaration forms is now streamlined, as David explains: "We import two containers of produce weekly, and checking the line items and different categories is now all set up and the man doing that job just breezes through it. Previously, he would spend about three or four hours; now it takes him 30 minutes – and that's if he's slow and takes a coffee break!" The ability to select items by date and group them together also eases the declaration process. Other benefits of the Blue Link application include better reports, analysis and tracking. For example, instead of the need to go back to inventory and check all items (tariff codes, country of origin, weight and size), the products are now calculated by cost, which is more accurate. "Just because it's more expensive doesn't mean it cost us a lot more to bring it in," explains David. "This system is accurate to the penny. Better costing of the product means more efficiency, so we can make more profit. That makes us happy!" When asked about the reactions of the Customs department, David simply states: "The sheer fact that Customs haven't complained ... is very good. Says it all!" He adds, "There was bit of initial tweaking, but it's all fine now, and there are no complaints at all. We're ahead of the curve.

1. Case study

Ram has undertaken a research study to make a presentation to a rural marketing and promotion company to secure employment. He is impressed by the growth in rural retailing and thought that it can be an interesting field for investigation and discussion, since organized rural retailing is at its emerging stage; he assumed that there is a need to study the perceptions and expectations of farmers related to organized rural retail outlets to evolve improvement strategies.

Reasons for entry

An analysis of published literature revealed that the companies entering this arena are lured by two factors, i.e. the vast untapped potential of the rural market and the slowly increasing purchasing power of the rural population. Lured by the hidden potential DSCL has started utility shopping centers called "Hariyal Kissan Bazars", Godrej Agrovet has initiated "Godrej Adhar" and Tata chemicals has started "Tata Kisan Sansar" one stop shopping malls for farmers that offer a wide range of products, from agri inputs and lifestyle product items.

Objectives and methodology of the study

The study aims at exploring the awareness and preferences of farmers regarding rural retail outlets and analysis of farmer's satisfaction with respect to various services provided by them.

Three companies have rural retail outlets in Punjab DCM i.e. Shriram Consolidated Ltd., Godrej Agrovet and Tata Chemical were chosen by Ram. Two retail outlets of each company were selected at random; two villages were selected in the

close vicinity of each selected outlet. By employing a questionnaire, data was obtained from the sample of 60 buyers and 60 non-buyers. Data was analyzed to see whether there was significant difference between the response of buyers and non buyers using the t-test.

Findings

It was found that there is no significant difference in the views between buyers and non buyers.

<u>Awareness</u> – All the farmers, even the non buyers were aware about the existence of organized rural retail outlets. advertisements, exhibitions and kisan melas, farmers meetings, field trials/demonstrations and fellow farmers constituted main source of information. Newspapers and company websites are help to some farmers.

<u>Retail preferences</u> – However only 39 % of them visited these outlets. The farmers who purchased from organized retail outlets gave the following reasons for their purchase : availability of better quality, technical services, veterinary services and home delivery. Others preferred to buy from other stores due to reasons like: credit facility, lower prices and easy availability.

<u>Products/services purchased</u> – Many visit the retail outlet for agri-inputs and technical knowledge. Around 20 - 15 % of them purchase FMCG.

<u>Satisfaction</u> – It was found that the gap between the expectations and perceptions was the highest for credit facility and the minimum for technical knowledge. There is less gap for parameters such as field trials/demonstrations, water testing, soil testing, farmers meetings, veterinary services and technical knowledge.

1. Case Study.

Wilson Engineering Limited (WEL) was the manufacture and seller of generators. The company offered a wide range of products and developed a vertically integrated supply chain for components. With a Mission of becoming a global leader and a provider of state of the art generators at the most competitive price, WEL followed an aggressive acquisition plan to expand its technology base and product range. To comply with its mission the strength of its staff increased from 36 in 1990 to over 10,000.

The same year the company started receiving complaints about defects in the generators supplied to its customers in The UK. WEL was able to address the issue promptly and offered solutions which were appreciated by its customers. However the incident had an adverse effect on its reputation which affected the inflow of orders adversely. The industry considered this issue negatively and many were apprehensive about WEL's capability to provide reliable products.

Just as the issue seemed to be under control a year later reports of cracks in generator parts supplied by WEL appeared in Industry Journals. It was reported that the cracking was because of extreme gusts in the region. There were reports about lower availability, its incompatibility with the electricity grid and regular breakdowns due to cold weather in projects managed by Natural Energy Ltd. one of the largest customers of WEL. Natural Energy Ltd. had purchased 200 generators from WEL and had called for an emergency meeting with WEL officials. WEL accepted the defects and vowed to analyze the problem and give a solution within 2 months.

2 months later the VP-Quality Management of WEL announced that the company had come up with a plan to overcome the issue occurring at Natural Energy Ltd. He declared that WEL would undertake up a retrofit program to solve the cracking problem in the generators. The company announced that the retrofit required structural strengthening of all the parts and would complete the task within 6 months and for this purpose the company had made provision of an amount of \$100 million. After the announcement WEL's stock crashed by 20%.

1. Case Study.

Fruit and vegetable drying

Fruits and vegetables play an important role in providing the body with essential vitamins and minerals which when deficient, can cause malnutrition (Utete and Tembo, 1996). In the samallholder sector of Zimbabwe, fresh vegetables are available in large quantities in the dry season while fruits are abundant in the wet season. When production exceeds the family consumption needs and demand levels of the local markets, producers face huge problems in trying to access urban markets. These include lack of market information and marketing intelligence, high perishability of horticultural commodities and lack of refrigerated transport services and poor road networks. More often than not, high value produce is put to waste.

A wide variety of vegetables and fruits are processed into dried products and the majority of vegetables processed are indigenous varieties. Preservation relies on the removal of moisture by drying. An acid dip sulphur dioxide may also be used to reduce the number of contaminating micro-organisms (Fellows, 1997) but this is not commonly practiced in Zimbabwe. Dried products are obtained from apple, mango, guava, banana, paw-paw, tomatoes, onions, cabbages, rape,

covo, cowpea leaves, pumpkin leaves, mustard leaves and okra. It is more common to find dried vegetables rather than fruits on the vendors market. For a significant number of processors, processing is a traditional activity adopted to enhance household food security during the agricultural off-season when access to fresh produce is limited. Some surplus may be sold locally to generate income. The few enterprises that produce the dried products at medium-scale, sell their products in the up-market shops and local tourist resort areas. The Murewa Food Processors' Association is one of the few enterprises which exports small volumes of dried fruits, but it does not have firm contracts in export markets.

Most of the existing fruit and vegetable processors are informal in nature and range in size from small to medium. They are normally referred to as cottage industries as they operate from residential homes. Drying of fruits is still a novel idea among both processors and local consumers. However, there is evident increase in the supply of processed fruits and vegetables as various such commodities are now available in the up-market shops in towns and tourist resort areas but in better quality.

Prior to 1987, information security at Aetna was the responsibility of three corporate level entities. The computer security function established information systems security policy, the information systems function handled the computer center backup and disaster recovery planning and the facilities risk management group was responsible for other security, safety and insurance activities. In 1998, the company implemented a comprehensive information security awareness program managed by ISPP group of five employees. The goal is to persuade all of its users to employ good security practices and behaviour.

The key element of Aetna's security program is its mandatory web based InfoSec exam accessible through SecurNet to be completed by all users, every year, including managers. Moreover, these exams are role based and users are accordingly trained. Implementation of InfoSec exam is done in phased manner. One week before InfoSec exam becomes operational ; ISPP sends mail to Helpdesk to warm them of potential increase in user calls for assistance.

After a few days, managers are notified to remind the purpose and importance of security. All employees are similarly informed by mail about the InfoSec exam in increments to avoid undue burden on infrastructure and Help support group. New users are sent special notification on first day of employment providing link to Orientation program including Information Security overview that also includes link to InfoSec exam to be completed within one month of hire.

Employees must go through online registration process for exam. User can complete the exam module wise at their convenience and do not need to be finished all at once. Each employee can printout a personalized certificate of completion with a customized Information Security Message after the exam is finished. Employees display these certificates in their work areas which serve to reinforce the importance of security throughout the organization.

ISPP group regularly analyses exam statistics to evaluate completion progress according to individual employee groups. Management can keep track of employees' exam completion and e-mail reminders are sent from ISPP to management further to specific users who need to complete their exams.

Aetna's comprehensive monitoring and communication plans have resulted in an impressive compliance rate. All its users and managers have completed every InfoSec exam each year since 2000.

1. Case Study

A decade ago with the aim to create pollution free roads the US Government adopted a regulation mandating specific standards for the quality of gasoline sold in the United States. Oil producing countries protested, Venezuela in particular. According to them this regulation was unfair as 2/3 of Venezuela oil export was dependents on US markets. The dispute created controversy and tension between the two countries.

The aim of the Environment Protection Agency (EPA) under the Clean Air Act (CAA) was to improve quality of air, which was deteriorated due to gasoline emissions. The regulation imposed different standards on domestic and imported gasoline. It was challenged by Venezuela in the WTO citing it as a violation of the principle of national treatment. Venezuela argued that imported goods once in the domestic market of the member country cannot receive treatment less favorably than the internally produced goods. Venezuelan gasoline imported in the US was subject to test standards much more rigorous than those imposed on gasoline produced in the United States.

The US argued that this discrimination was devoid under Article 20 of the GATT, which states that under certain conditions, countries can take measures that would be normally outlawed in order to conserve exhaustible natural resources, protect human, animal or plant life. One of the major conditions is that these measures should not be protectionism in disguise.

Venezuela refuted the argument saying if US wanted very clean gasoline, they should submit both domestic and imported gasoline to same high standards. The new regulation had important economic impact for Venezuela as producing gasoline as requested by US represented an expense of 40 million dollars in the first three years. The US market was extremely important for Venezuela and its export earnings.

The WTO panel consisting of three independent experts chosen by both sides on a dispute ruled that imported gasoline was indeed discriminated against and this could not be justified even under Article 20. A month later US appealed the panels conclusions. The appeals were heard by appellate body of WTO. It is a permanent group of seven persons of recognized authority with demonstrated expertise in law and International Trade. The appellate body in two months confirmed the panels ruling that discrimination against imported gasoline was not justified under Article 20, but it ordered a broad interpretation of this provision.

Although the US was not satisfied with the outcome no further recourse was available. The Appellate body report and modified panel report were adopted by the Dispute Settlement Body in 1996 i.e. just in a year when panel was appointed. The complaining countries were satisfied with the outcome and the way the dispute was handled. The resolution confirmed that the dispute settlement system was working in a neutral way in which countries could trust. The European Union had substantial interest in this case and was the third party.

The US had to implement the ruling; it had to change its legislation. It took US 15 months to implement necessary changes in the legislation from the day the dispute was resolved.

But some analysts felt that ABC had become a victim of its own success. ABC expanded its production facilities rapidly in a bid to grow globally and to achieve its goal of becoming the number one auto maker in the world. ABC rapid growth affected its product quality with the company reportedly compromising on its manufacturing techniques. Customers began to face safety related problems in ABC vehicles. Later a series of recalls followed which put the company's reputation at risk. Analysts said that constant recalls had damaged the reputation and brand image of ABC and hindered its return to profitability. To achieve target of market share, ABC had sacrificed its quality and ignored its own management principles and customers, analysts said.

Air Nuigini- national carrier of Papua New Guinea (PNG) used to pay more than double the salaries to expatriate pilots compared to that of national pilots. In fact, national pilots are in no way inferior to expatriate pilots in skills and in performance in safety, regularity and punctuality. The salary discrimination was necessitated to attract foreign pilots due to shortage of national pilots. This practice was along with polices and practices of compensation management in other public and private organisations in PNG.

These practices resulted in the dissatisfaction among national pilots that prompted them to look for opportunities in other countries. The fast growth of airlines industry in various countries led to shortage of pilots resulting in higher salaries for pilots across the countries. Majority of the pilots of PNG who are dissatisfied with the salaries in Air Nuigini based on skill levels and performance records procured jobs in various airline companies particularly in the middle-east with triple the salary levels of their previous jobs in Air Nuigini. In fact, one of the former national pilot of PNG got the job of the Deputy CEO of one of the middleeast airline company.

The migration of PNG pilots reached the peak level in April 2008 and ultimately, Air Nuigini did not have required number of pilots to operate their flights and Air Nuigini had to cancel some its domestic flights and delay the operation of international flights, resulting in halting the wings of Air Nuigini flights.

Nestle Consolidation

In light of one of the contracts approaching review and the end of lease agreements at two of the sites, Nestlé decided to take the opportunity to review its warehousing and distribution strategy in the UK, turning to total logistics to undertake a thorough and independent assessment of its current and future supply chain needs. Ian Hill, Director of Logistics at Nestlé UK, explains the background to the project: "For many reasons, we had reached a point where we were faced with various options on our three-site strategy. The time was right to bring in a fresh pair of eyes to review our distribution network. With our complex mix of dry and wet goods, including water, coffee, confectionery and a mix of perishable goods, we wanted to explore what options were there for us - and the Total Logistics' team was the obvious choice given our longstanding relationship with the supply chain consultancy". The main task facing the Nestlé team and Total Logistics' supply chain consultants was to develop a meaningful model by which to really understand the pros and cons of every option that was available. This already complex scenario was made even more challenging due to the diverse and expansive nature of Nestlé's product range and a large number of end-markets. While the York, Bardon and Scunthorpe sites handled foodstuffs including water, confectionery, cereals and coffee the latter also coped with the huge seasonal demands for confectionery products during periods such as Easter and Christmas. To add to the complex picture, Scunthorpe also used different technologies to service the international export market, dispatching the product to Europe and further afield via deep-sea routes. Whereas Scunthorpe was characterised by high density, drive-in racking, with temperature and humidity controls, Bardon

and York used automated high bay storage units that did not require as sophisticated environmental management.

Peter Roan, Director at Total Logistics, said: "This project was complex from a supply chain modelling perspective, as it not only included an analysis of inbound and outbound flows, transport costs, road links and inventory issues but also risk and service factors created by any new network proposed." "Time was also a big factor here, given the fact that we needed to make recommendations and support the implementation to ensure the client was ready and able to satisfy the crucial peak demand period of Christmas. In short, we had a window of just six weeks to completely review and make recommendations on Nestlé's UK distribution network strategy".

Total Logistics set to work developing an assessment tool to look at the impact of putting different business streams into the same or new facilities. For example, the benefit of keeping seasonal and export confectionery streams in the same facility as they have largely counter-cyclical storage needs was a major consideration. Another key consideration was quality assurance, as a large number of confectionery items had to be stored at a temperature of 80c and 65 percent relative humidity. A further element to the assessment model included an analysis of transport and warehousing costs, including inbound and outbound flows. Particular attention was paid to the potential synergies that could be obtained by combining different streams to increase drop size, thus reducing the number of road miles and journeys required. In all, 16 different scenarious were developed based on the existing facilities and other potential locations in the UK.

In the final analysis, it was decided that a twin site solution provided the greatest cost saving to Nestlé while enabling it to improve flexibility and delivery performance to supermarkets and other key retailers in the UK and further afield. Although its delivery performance was already at 99.4 percent, Nestlé was confident that concentration to two locations would allow the already high customer service levels to be improved. Due to its central location and existing potential for development, it was decided that the Bardon site was the obvious choice to centralize supply chain operations. "While our recommendation to consolidate much of Nestle's food and drink distribution under one roof has reduced the overall cost of distribution, the move has enabled the company to combine its business stream and product supply chains to create far greater flexibility." "Nestlé now has a much more robust logistics operation that will enable it to meet the growing need to deliver more frequent, lower volume drops to retailers. As well as supporting the Nestlé team through this crucial period, we were also able to work with them on the risk management issues raised by a twin site strategy,

holding a risk assessment workshop". Accordingly, Nestlé has worked hard to ensure the design of the new Bardon site takes issues such as fire protection and security very seriously. The communications infrastructure at the site has also been a key consideration during the implementation phase that saw the successful commissioning of the extension in May 2009 and completion to fit for purpose in July of that year. Ian Hill is delighted with the final outcome of the project. He said: "Given the tight timescale and the perishable nature of our products, there was potentially a lot at stake by migrating many of our famous brands to the Bardon site. The total logistics team added significantly to the process, offering strategic insights and practical support along the way".

It is not often acknowledged that Raj Bahadur Mohan Singh Oberoi, 100, chairman of an empire of 29 hotels spanning most of the world's landmass is also the man who pioneered India as a brand, way back when it was only a bazaar of begging bowls and exotica. At 90, he looked back in something close to awe and said, "I often wonder how I did it".

Certainly he did not give much of the credit to luck. True, he stood at the right time at the right place to confront his destiny, but this was just physical circumstances. What he did with the situation was amazing for a man from the boon docks of Bhaun, with little education, and really not to the manor born.

Indeed, if anything, the Rai Bahadur made his fortune out of calamity. If his father hadn't died of cholera when he was only an infant, his mother would not have returned to the ancestral home which gave Oberoi the connections and contacts that helped him raise money later to buy his first hotel, the Clarke's at Simla. If he hadn't flunked the interview for his first job as clerk with the Government of India, he would never have made his way to the Simla Mall, gazed in wonderment at the glitter of the Cecil and made up his mind that he would work there. If a fatal bug in the water supply, hadn't laid low Calcutta's mighty Grant Hotel, it would never have been up for grabs. Again Oberoi just

chanced to hear about it at the Delhi railway station when he was leaving to return to base in Simla. He simply changed his ticket and his direction and went to mint millions out of wartime Calcutta another catastrophe. Life served his lemons regularly but with even greater regularity did the Rai Bahadur make lemonade.

The story of Rai Bahadur is all the more impressive because there was nothing in his background to suggest that he would be able to create the world-class ambience and sophistication for which the group is now celebrated, that he would be able to foresee India's current positioning in the global market, while doffing a deferential hat to history when it was demanded.

For instance, when other hotels were cramming their lobbies with brassbound chests and colonial nostalgia, Oberoi created the first international business hotel, the Oberoi Intercontinental in Delhi. However, in the Mena House, Egypt, and the Windsor, Australia, he went to extraordinary lengths and expense to produce authenticity to the last detail, including country-wide searches for memories and memorabilia. In order to replicate the flooring in the Windsor, he tracked down the original supplier of the tiles in distant Stoke-on-Trent, England.

Celebrating his 100th birthday, with his mind almost as clear as it was 50 years ago, perhaps the one philosophy responsible for his grand success might be his dictum. "I never worry. It clutters the brain. The problem may not happen, and even if it does, worrying will only come in the way of clear-headed solution".

A company was manufacturing heaters in different models with different capacity. A group of 10 workers were engaged n assembling heaters. At one workstation they are assembling parts with the help of tools and then heaters being transferred to another workstation for further process. After completion, inspector used to check for quality and working. Heater used to get packed in different containers.

The assembly line was properly balanced by industrial engineers who had used time and motion study to break jobs in subassembly task. The time required for each subassembly had also been balanced so that the task performed by the each worker was supposed to take exactly the same amount of time. The workers were paid on an hourly basis.

The inspector observed that morale amongst workers was low and there were a percentage of badly assembled heaters. Rejects caused by the worker rather than faulty materials were about 22%. After discussing the issue with management it was decided to have meeting with the workers. The workers were asked whether they would like to build heaters individually. Workers agreed with an option of going back to the old program if the new one did not work well. After several days of training each worker began to assemble entire heater.

The workers were motivated and supported by inspector. Productivity increased remarkably. Rejects caused by workers reduced to only 5% from 22%. Workers have responded positively and their morale was high and the workers did all the routine inspection by themselves. Inspector was posted on another post at other location.

Prakash Chand has been working as Production Assistant since 2001 in Bharat Zinc Limited, Visakhapatnam. Mr. Gangadhar at 4 pm on 15^{th} June 2007 gave a pocket containing semi processed zinc to Mr. Prakash and asked him to deliver it before 5 pm on the same day to Mr. Surjeet, the Laboratory Supervisor of Bharat Heavy Plates and Vessels. Mr. Prakash rushed to Bharat Heavy Plates and Vessels on a two wheeler and delivered the pocket personally to Mr. Surjeet at 4.45 pm on 15^{th} June 2007 and recorded the transaction in the register concerned of both the parties and left the office of Mr. Surjeet.

Mr. Prakash's vehicle foiled on the way and as such he was repairing the vehicle. At the same time there was storm and heavy rain from 5.30 p.m. to 7.30 p.m. Mr. Prakash parked his vehicle one side of the road and rushed to a nearby old house, which housed a liquor shop. The house completely collapsed at around 7 p.m. It was found at around 9 pm that all the people including Mr. Prakash died. The family members of Mr. Prakash approached Mr. Gangadhar at 11 a.m. on 16th June and informed him of the event. Then Gangadhar repented of the entire incident and has written a letter to the Human Resource Manager narrating the total incident that took place from 4 p.m. of 15th June to 11 a.m. of 16th June including the repair of Prakash's vehicle. Mr. Gangadhar in his letter requested the HR Manager to pay compensation to the wife of Mr. Prakash as Mr. Prakash died while performing his duty. The HR Manager, informed Mr. Gangadhar and the wife of Mr. Prakash that the company need not and will not pay compensation as the accident took place outside the working hours of the factory and outside the work place. Mr. Gangadhar and the wife of Mr. Prakash appealed to the CEO to look into the matter and do justice.

The farmers

Forty-seven farmer households growing certified organic asparagus in Srakaew Province are part of a special group of poor smallholders cultivating land belonging to the Royal family. Once farmers on this special site are deemed financially better off than when they joined the group, they are asked to leave the site to join other groups of farmers under contract with Swift. This enables other poor households to enter the group and benefit from its advantages.

The market

Swift Co. Ltd. is the sole outlet for the organic asparagus of the farmer group. Swift supplies fresh, frozen and precut fruits, vegetables and herbs to export customers in the United Kingdom, Japan and the Middle-east. The customers are very demanding; they require produce that is certified as organic according to their country's standards. Swift takes responsibility for the certification and thus pays for several certifications on behalf of the farmers' group.

The linkages

The farmers are given 2 rai (1 rai = 0.16 ha) of land each free of any lease. The land is located on Royal property given out to Swift to implement contract farming of organic asparagus. Swift signed an initial exclusive supply contract with the farmer group in 2002. The company trains these farmers on organic production methods and buys their whole harvest at a fixed price. This price is fixed for the duration of the contract of three years. A second contract was signed in 2005.

A pioneer in the business of organized retail in India, Foodmart is the first national chain of supermarkets. It provides customers with a wide range of quality products at a reasonable price everything under one roof, in a convenient location, in a clean, bright and functional ambience. Part of self-service format Foodmart follows the service of clearly marking on the shelf, relevant details of the product displayed, including the name, weight and price. This provides immense convenience to the shopper.

Food may be a necessity, but tastes change. Influenced by TV chefs, nutritional education and celebrity-endorsed diets, shoppers seek a constantly changing range of fresh, frozen, dried and packaged goods. Greater nutritional awareness among some consumer sectors has led to increased demand for organic and low-fat goods, while ready-to-serve meals continue to satisfy those with busy lives. To cater to all tastes, retailers have to offer more variety and more specialities while managing more suppliers, keeping prices low and staying in stock. For a growing number of food retailers, there is also now more to business than just food. Traditional grocery chains both large and small now stock toys, consumer electronics, house wares, clothing and other inedible products throughout their stores. This diversification has expanded the product catalogue even further and introduced new sourcing, forecasting and allocation challenges.

Retailers have to manage more product lines, more store label goods, and more promotions while maintaining high food safety standards and minimizing waste. Supply chain complexity has never been greater.

"Focus on Fresh" is another initiative at Foodmart, which is aimed at recognizing the strategic importance of this category, a stronger fresh offering increasing the frequency of customer visits. Fruits and Vegetables comprise a large portion of the sales in a Foodmart store. The supply chain in this category is very complicated normally but over the years, Foodmart has been able to identify suppliers and processes that simplify the chain resulting in efficiencies, better margins and better quality. Foodmart has also opened up a-fruit and vegetable consolidation center near Bangalore, to leverage the volumes currently being generated by stores in Chennai and Bangalore. 32 different types of vegetables are being sourced from these consolidation centers. On an average, 250 tons of fruits and vegetables a month are supplied from here to all Foodmart stores.

1. Case Study.

Wilson Engineering Limited (WEL) was the manufacture and seller of generators. The company offered a wide range of products and developed a vertically integrated supply chain for components. With a Mission of becoming a global leader and a provider of state of the art generators at the most competitive price, WEL followed an aggressive acquisition plan to expand its technology base and product range. To comply with its mission the strength of its staff increased from 36 in 1990 to over 10,000.

The same year the company started receiving complaints about defects in the generators supplied to its customers in The UK. WEL was able to address the issue promptly and offered solutions which were appreciated by its customers. However the incident had an adverse effect on its reputation which affected the inflow of orders adversely. The industry considered this issue negatively and many were apprehensive about WEL's capability to provide reliable products.

Just as the issue seemed to be under control a year later reports of cracks in generator parts supplied by WEL appeared in Industry Journals. It was reported that the cracking was because of extreme gusts in the region. There were reports about lower availability, its incompatibility with the electricity grid and regular breakdowns due to cold weather in projects managed by Natural Energy Ltd. one of the largest customers of WEL. Natural Energy Ltd. had purchased 200 generators from WEL and had called for an emergency meeting with WEL officials. WEL accepted the defects and vowed to analyze the problem and give a solution within 2 months.

2 months later the VP-Quality Management of WEL announced that the company had come up with a plan to overcome the issue occurring at Natural Energy Ltd. He declared that WEL would undertake up a retrofit program to solve the cracking problem in the generators. The company announced that the retrofit required structural strengthening of all the parts and would complete the task within 6 months and for this purpose the company had made provision of an amount of \$100 million. After the announcement WEL's stock crashed by 20%.

1. Case Study.

Fruit and vegetable drying

Fruits and vegetables play an important role in providing the body with essential vitamins and minerals which when deficient, can cause malnutrition (Utete and Tembo, 1996). In the samallholder sector of Zimbabwe, fresh vegetables are available in large quantities in the dry season while fruits are abundant in the wet season. When production exceeds the family consumption needs and demand levels of the local markets, producers face huge problems in trying to access urban markets. These include lack of market information and marketing intelligence, high perishability of horticultural commodities and lack of refrigerated transport services and poor road networks. More often than not, high value produce is put to waste.

A wide variety of vegetables and fruits are processed into dried products and the majority of vegetables processed are indigenous varieties. Preservation relies on the removal of moisture by drying. An acid dip sulphur dioxide may also be used to reduce the number of contaminating micro-organisms (Fellows, 1997) but this is not commonly practiced in Zimbabwe. Dried products are obtained from apple, mango, guava, banana, paw-paw, tomatoes, onions, cabbages, rape,

covo, cowpea leaves, pumpkin leaves, mustard leaves and okra. It is more common to find dried vegetables rather than fruits on the vendors market. For a significant number of processors, processing is a traditional activity adopted to enhance household food security during the agricultural off-season when access to fresh produce is limited. Some surplus may be sold locally to generate income. The few enterprises that produce the dried products at medium-scale, sell their products in the up-market shops and local tourist resort areas. The Murewa Food Processors' Association is one of the few enterprises which exports small volumes of dried fruits, but it does not have firm contracts in export markets.

Most of the existing fruit and vegetable processors are informal in nature and range in size from small to medium. They are normally referred to as cottage industries as they operate from residential homes. Drying of fruits is still a novel idea among both processors and local consumers. However, there is evident increase in the supply of processed fruits and vegetables as various such commodities are now available in the up-market shops in towns and tourist resort areas but in better quality.




Fig. 1 : Layout of the Bank

James was a 30 year old American sent by his Mexico-based company, to set up a buying office in India. The new office's main mission was to source large quantities of consumer goods in India : cotton piece goods, garments accessories and shoes, as well as industrial products such as tent fabrics and cost iron components. India's Ministry of foreign trade had invited James's company to open this buying office because they knew it would promote exports, bring in badly-needed foreign exchange and provide manufacturing know-how to Indian factories.

James's was in fact, the first international sourcing office to be located anywhere in South Asia. The MFT wanted it to succeed so that other Western and Japanese companies could be persuaded to establish similar procurement offices. The expatriate manager decided to set up the new office in the capital, New Delhi, because he knew he would have to meet frequently with senior government officials. Since the Indian government closely regulated all trade and industry, James often found it necessary to help his suppliers obtain import license for the semi-manufactures and components they required to produce the finished goods his company had ordered.

James found these government meetings frustrating. Even though he always phoned to make firm appointments, the bureaucrats usually kept him waiting, for half an hour or more. Not only that, his meeting would be continuously interrupted by phone calls and an announced visitors, as well as by clerks bringing in stacks of letters and documents, to be signed. Because of all the waiting and the constant interruptions, it regularly took him half a day or more to accomplish something that could have been done back home in 20 minutes.

Three months into this assignment James began to think about requesting a transfer to a more congenial part of the world – "somewhere where things work". He just could not understand why the Indian officials were being so rude. Why did they keep him waiting? Why did not the bureaucrats hold their incoming calls and sign those papers after the meeting so as to avoid the constant interruptions?

1. Case Study :

Tuna is arguably one of the most well-known and abundant of fish, found in large quantities at supermarkets and convenience stores around the world. It is such a popular sight in its canned form that one may have even dissociated it from its origins as a fish, until reminded of the amusing slogan-cum-brand, 'chicken of the sea'. As such, it is safe to say that tuna enjoys as much popularity among consumers as the humble and ubiquitous chicken.

On the production side, easy accessibility and popularity translates into big business, thriving markets and fierce competition. For producers of canned tuna, the fish is their livelihood, an important source of income and an industry of serious economic significance, contributing as it does to the national balance of payments, the employment rate and, subsequently, a productive and healthy social climate.

This is especially true in the case of Thailand, the world's third-largest producer of canned tuna and the largest exporter, accounting for 31% of the global volume of exports. As of 2000, the United States has remained Thailand's biggest export destination, followed by the European Community (EC) and then Canada. (1) Since Thailand's tuna industry is export-oriented, with almost all its production intended for overseas markets, foreign import restrictions and regulations wield considerable impact on its growth and overall dynamism. This is where Thailand encountered difficulties with one of its major trading partners – the EC.

Despite its impressive world ranking, producers of canned tuna in Thailand were convinced that their industry was capable of considerably better performance given more equitable access to the EC market. This inequity existed primarily in the form of a preferential tariff granted by the EC to canned tuna producers from the African, Caribbean and Pacific States (ACP countries), a status consolidated in the Continuo Agreement (ACP Agreement) of 3 February 2000 between the EC and the ACP countries. While ACP countries were enjoying zero tariffs on tuna imports, other countries such as Thailand were continuing to face an inhibiting tariff of 24%, which was proving detrimental to the legitimate economic interests of Thailand as a major producer of canned tuna. Furthermore, zero import tariffs for ACP countries encouraged investors increasingly to view the ACP countries as a favourable investment destination, in contrast to Thailand, undermining the cost and other comparative advantages that Thailand has to offer.
