The tests have to be conducted throughout year on pre-defined dates and places as designated by the competent authorities.

Terms and Conditions:

1. Maximum number of outreach activities will be 10.
2. Number of samples needs to be tested per activity varies from minimum of 100 to maximum of 1000.
3. Samples has to be collected onsite at University Health Centre as per the pre-determined schedule. This schedule will be intimated well in advance to the lab.
4. Rates should be inclusive of all taxes and other charges such as sample collection, transport charges etc.
5. Reports should be given in both soft and hard copy duly signed by authorized pathologist. Reports signed by technicians will not be entertained. Reports has to be submitted within designated time period in consultation with university medical officer.
6. Deputing technician/phlebotomist and collecting samples using necessary aseptic precautions and disposing biomedical waste will be responsibility of the lab.
7. Quotations filled by collection centres of corporate labs will not be entertained however if a corporate lab has its authorized testing centre stationed within Solapur city can submit their quotations. Necessary documentary proof must be attached.
8. Labs attached with NABH accredited hospitals will be considered eligible to send their quotations.
9. Lab registration certificates, NABL/NABH accreditation certificate (if applicable) and Pathologist certificate must be attached with the quotation.
10. NABL accredited labs will be given preference.
11. University reserves right to change the terms and conditions of the quotation and to accept or reject the quotations. Decision of university authorities will be final.
12. No advance payments are admissible. Full payment will be done only after satisfactory completion of activity.
