TERMS & CONDITIONS FOR COMPREHENSIVE AMC

- Payment will be 50 % in advance at start of the contract, 25% payment after 6
 Months and remaining 25% after completion of contract of one year.
- 2. This Contract extends only to the problems arising out of normal functioning of the equipment which are mentioned above and does not cover breakdowns arising out of, whether partly or wholly, misuse of the equipment, or its use under environmental conditions or thefts or unsuitable for electronics equipment or arising out of any circumstances not normal. The agreement specially excludes damages caused due to fire, theft, riots, accidents and other exceptional circumstances.
- Second Party engineer shall endeavor to attend the service call in Punyashlok Ahilyadevi Holkar Solapur University.
- 4. The First Party shall not directly, or indirectly open, alter, try to tamper or in any way do any act which will result in intruding with the internal operation of the system and peripheral units (except routine input/output, data processing) and do any modifications to the configuration supplied by Second Party without the presence of the Second Party's engineer and/or without written prior approval of Second Party.
- No person other than authorized personnel of Second Party shall have the authority to alter or change any item in the system or peripheral unit during the period of the contract.
- The Contract will cover preventive and breakdown maintenance Hotspot Server, Radius Server, Outdoor Access Point, Indoor Access Point, P2MP Sender, P2MP Receiver, etc.
- 7. Comprehensive Annual contract covers all the devices mentioned therein above and the maintenance and replacement in free of cost except wire damage for changing of cables it is chargeable cost to first party because cable is not covered in contract.
- 8. The Contract will be considered null and void and System warranty automatically stands terminated without any financial obligations if the First Party permits a third party to undertake repairs etc., or makes any modifications, change of locations, alterations of any sort without prior written consent from Second Party.
- 9. Physical Damage of Parts or Devices will not be covered under AMC.

- 10. While every effort will be made to replace failed components, in case of non-availability of spares, Second Party may recommend an upgrade at his own cost, expeditiously.
- 11. Second Party shall not disclose to any one, any information of confidential nature which might have come to our knowledge in the course of the contract in whatsoever manner, which may adversely affect the interest of the First Party.
- 12. Maintenance of equipment to be provided at the specified location only and within University Campus, Solapur as a limit.
- 13. The First Party will permit Second Party engineer to have complete access to the system and provide necessary manpower assistance.
- 14. The contract charges will remain firm till completion of the contract period and the prevailing rates at the time of renewal shall be applicable.
- 15. Both the parties shall not be liable to each other for delay in or failure of the performance of the respective obligations due to causes, contingencies, or circumstances beyond their reasonable control, such as act of God, change in Govt. policy, accidents, strikes etc.
- 16. The First Party shall not be entitled to assign this service arrangement or any benefit or interest here in to any other person or external agency without the prior written consent of Second Party during the period of contract.
- 17. In case of breach in the terms, either party has the right to terminate the contract giving one month's prior notice.
- 18. The First Party should inform the Second Party either in writing or telephonically about the nature of complaint and define the time period to rectify the same.
- 19. The period of rectification of the defect shall start on receipt of complaint communicated either by telephone or e-mail.
- 20. If the Second Party fails to rectify the defect within the stipulated time without any genuine reason, and if the said work is carried out by the First Party through other party from the open market, in this situation the amount incurred towards the expenses for this work shall be recovered from the Second Party.
- 21. If any dispute arises between the First Party and Second Party, the said dispute is to be resolved by mutual discussion and in case if the discussion is not fruitful at that time the decision given by the Vice-Chancellor, Punyashlok Ahilyadevi Holkar Solapur University, Solapur shall be final and binding on both the parties.

- 22. Security deposit shall be at 5% cost of the work (Rs. 15000/-) The security deposit shall be returned after completion of the AMC period successfully.
- 23. The second party shall not demand any price hike during the agreement period.
- 24. The quotation publish for this purpose shall from part & partial of agreement.
- 25. Violation of the above conditions shall give right to take appropriate action against the second party.
- 26. If the second party fails to rectify the complaint, then the fine of Rs. 500/- per day may be imposed by the university.
- 27. If the service of the second party is not satisfactory then the university may terminate the agreement and may also forfeit the security deposit.
- 28. The jurisdiction of this agreement shall be within the Courts situated in Solapur.
