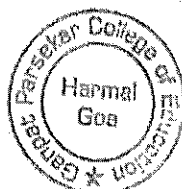
### MEMORANDUM OF UNDERSTANDING

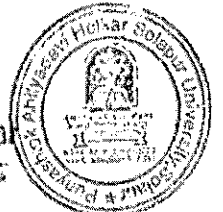

**WHEREAS, Punyashlok Ahilyadevi Holkar Solapur University, Solapur, under the aegis of was established in 2004 as per notification of Government of Maharashtra.**

**AND WHEREAS,**

In consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

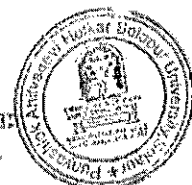
**1. Purpose and Scope - This MOU shall commemorate the parties' intent to enter into but not be limited to, the following types of collaboration:**

## 2. Objectives - The Parties agree as follows:

1. To enhance development in the field of Education by collaboration in research, and extension.
2. One week of Student exchange, of both parties, once a year, after executing separate MoU/agreement in this regard.
3. The first party conducts seminars/ Conferences/workshops in Collaboration with the second party.
4. The second party shall provide guidance and consultancy to the first party to conduct extension programs in the local schools.

## 3. Financial Implications -


- a. Travel, Accommodation and honorarium for the visiting faculty of PAHSUS to visit and conduct sessions at GPCOE will be borne by GPCOE only after prior consent of the parties.
- b. Travel, Accommodation and honorarium for the visiting faculty of GPCOE to visit and conduct sessions at PAHSUS will be borne by PAHSUS only after prior consent of the parties.
- c. In case of attending Seminars/workshops/conferences at each other's venue, both parties registration fees shall be waived.
- d. Student accommodation during student exchange shall be the responsibility of the Host institution.
- e. No other financial obligations exist between the parties.

## 4. Terms of Memorandum -

The Parties acknowledge that this Memorandum of Understanding does not in any way give rise to any right or permission to use or to be associated with each Party's infrastructure/ Administration or Intellectual property.

## 5. Representations and Warranties -

Both Parties represent that they are fully authorized to enter into this MOU. The performance and obligations of either Party will not violate or infringe upon the rights of any third party or violate any other MOU between the Parties, individually, and any other person, organization, or business or any law or governmental regulation.

**6. Severability —**

In the event any provision of this MOU is deemed invalid or unenforceable, in whole or in part, that part shall be severed from the remainder of the MOU and all other provisions should continue in full force and effect as valid and enforceable.

**7. Implementation:**

In order to carry out and fulfil the aims of this MOU, each party shall identify a contact person to coordinate the development of each endeavour and conduct joint activities.

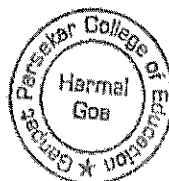
**8. Revision, Variation and Amendment —**

Either Party may request in writing a revision, variation or amendment of this Memorandum of Understanding. Any such revision, variation or amendment agreed to by Parties shall be in writing and shall form part of this Memorandum of Understanding. Such revision, and variation of amendment shall come into force on such date as may be determined by the Parties.

**9. Termination -** The Memorandum of Understanding can be terminated by either party giving the other party, a prior written notice of not less than Six months of its intention to do so, but without dishonouring any commitment entered into prior to the date of termination notice and no party shall leave its comment unfinished which may result in tangible losses to the other party.

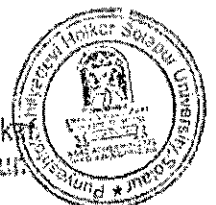
**10.** The duration of MOU will be THREE YEARS and likely to be continued upon mutual agreements between the parties concerned.
