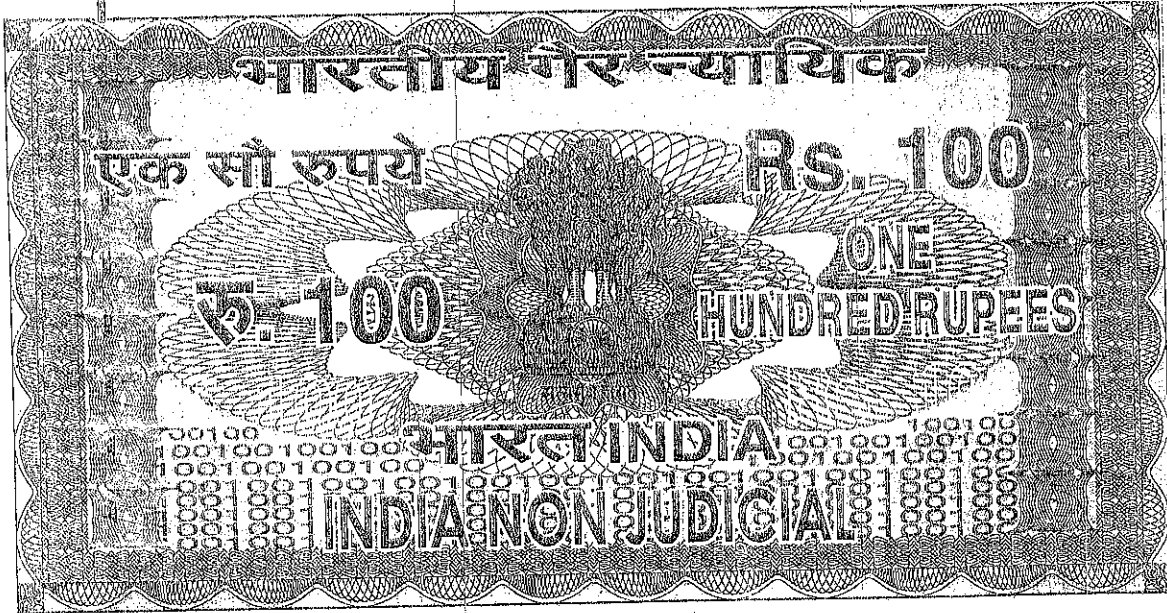

### Memorandum of Understanding

This Memorandum of Understanding ("MoU") is entered into this 06<sup>th</sup> day of May 2024

### BY AND BETWEEN

Mahatma Phule Renewable Energy & Infrastructure Technology Limited is established and the same is mentioned in the Govt. Resolution dt. 10.07.2023 bearing No. 202307101851060722, a company having its registered office at 5th floor, Pinnacle Corporate Park, next to Trade Centre, Bandra Kurla Complex, Bandra East, Mumbai, Maharashtra 400051 (hereinafter referred to as 'MAHAPREIT'), which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns, of the of the FIRST PART;

And

Punyashlok Ahilyadevi Holkar Solapur University, Solapur, Maharashtra - 431255 is established by Govt. of Maharashtra vide. Gazette dt. 22.07.2004, (hereinafter referred to as "PAHSUS") which expression shall unless excluded by or repugnant to the context or meaning thereof be deemed to include its successors and permitted assignees) of the SECOND PART;

(Hereinafter MAHAPREIT and PAHSUS may be referred to each as the "Party" and collectively as the "Parties").

**Whereas**

- a. MAHAPREIT, engaged in Renewable Energy & Infrastructure Technology Projects with focus on Emerging Technology Areas, Infrastructure, Renewable Energy, e-Mobility, Energy Audit & Correction Systems and Environment Projects.
- b. PAHSUS is established on August 1, 2004, PAHSUS is keen for working on numerous aspects of technological advancements in the energy sector, including the use of photovoltaic cells to convert solar energy into electricity, harvesting solar energy for the production of steam, solar cooking, solar drying, hydrogen fuels, lithium ion batteries, life cycle analysis, and other relevant energy-related fields.
- c. Hence, MAHAPREIT and PAHSUS have mutually agreed to associate together to create a framework for a collaborative activity under which the Parties will implement the projects identified by MAHAPREIT and PAHSUS in Maharashtra
- d. This MoU would lay out a broad framework of possibilities and express mutual willingness to work together.
- e. One of the key objectives of this agreement is to define and execute technology and practice trials in renewable energy
- f. This MoU shall be non-binding, with no financial obligation to other party, but outlines the proposed and agreed (Non-legal) general terms and conditions between the Parties in pursuing the joint activities as per project and, subsequently, shall be the outline of the provisions of a comprehensive project specific definitive agreement ("Definitive Agreement") upon mutual written confirmation.
- g. This MoU shall act as an umbrella arrangement under which various projects could be structured and placed for association. The collaborative specifics would be worked out and placed as firm agreement for each identified project based on the framework defined in this MoU.

In view of the above, it is agreed as follows:

**1. Understanding**

The Parties will identify the projects jointly in the areas mentioned in Recital (c) above on non-exclusive basis and discuss the same before proceeding further with any project. The understanding between the parties is on project-to-project basis to execute the project at the mutually agreed terms and conditions.

**2. Terms of Termination:**

This MoU shall commence on the Effective Date and end on the date of entering into a Definitive Agreement(s) for the specified Project/work as agreed between the Parties or the date on which this MoU is terminated at the option of either Party, as provided for herein, whichever occurs earlier.

#### 4. Specific Roles and Responsibilities of the Parties

##### a. Role of MAHAPREIT

- i. To identify the projects and deliver elements identified and finalized under Definitive Agreements for Projects;
- ii. Responsibility of end-to-end implementation within agreed timelines in close coordination with PAHSUS as decided in the Definitive Agreement;
- iii. It shall assist and extend the necessary co-operation required by the parties for implementation of the project;
- iv. It shall facilitate in getting any necessary clearances/approvals/consents required from any of the government authorities for the implementation of the Project, if required;
- v. Any other activity agreed between the Parties based on project specific requirements and identified in the Scope of Work and decided mutually in the Definitive Agreement.

##### b. Role of PAHSUS

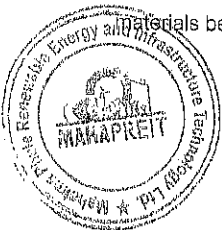
- i. To provide details related to site and energy consumption of the PAHSUS campus.
- ii. To identify and coordinate with stakeholders from different PAHSUS campuses and assist in coordination for Open Access.
- iii. As a part of Definitive Agreement, provide land available at PAHSUS campus for installation of solar PV systems for project identified mutually.
- iv. Program management support
- v. Find funding sources, if/as required.
- vi. Ensure periodic/ annual review of collaboration.

#### 5. Amendment:

This MoU may be amended only by written agreement of the Parties.

#### 6. Intellectual Property:

Each party shall retain full ownership and copyright for any and all materials they produce. This MoU shall not be construed to grant to either Party any license to use the logo or printed materials of the other Party, except in such form and manner as may be approved with the prior written consent of the Party to whom such logo or printed materials belong. Any and all requests for use of the logo or printed materials of a Party shall be submitted to the Party to whom such logo or materials belong and will require such Party's written approval prior to any such use.



11. Exclusions
