1.1 Preamble:

This course acquaints students with the constitutional design of state structures and institutions, and their actual working overtime. The Indian Constitution accommodates Conflicting impulses (of liberty and justice, territorial decentralization and a strong union, forInstance) within itself. The course traces the embodiment of some of these conflicts in Constitutional provisions, and shows how these have played out in political practice. It further encourages a study of state institutions in their mutual interaction, and in interaction with the larger extra-constitutional environment. The syllabus will help them develop interest in reading Political Process written worldwide.

Besides the knowledge of existing topics, the students will be equipped with applied skills of Political Process by virtue of the additional components.
